AN ORDINANCE LEVYING TAXES FOR ALL TOWN PURPOSES FOR THE LAKE VILLA TOWNSHIP, LAKE COUNTY, ILLINOIS FOR THE TAX YEAR 2016, COLLECTABLE IN 2017.

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF LAKE VILLA TOWNSHIP, LAKE COUNTY ILLINOIS, AS FOLLOWS:
