


TAX LEVY ORDINANCE

LAKE VILLA TOWNSHIP ROAD DISTRICT

ORDINANCE No. 2017- 5

AN ORDINANCE LEVYING TAXES FOR ALL ROAD PURPOSES FOR THE LAKE VILLA TOWNSHIP ROAD DISTRICT, LAKE COUNTY, ILLINOIS FOR THE TAX YEAR 2017, COLLECTABLE IN 2018,



BE IT ORDAINED by the Board of Trustees of Lake Villa Township, Lake County, Illinois, as follows:

SECTION 1: That the sum of \$2,700,000.00 two million five hundred and sixty eight thousand five hundred and 00/100 are hereby levied upon all property subject to taxation within the township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the township highway department as required by statute or voted by the people in accordance with the law, for such purposes as: General Road, Permanent Road, Equipment & Building, General Insurance, IMRF & FICA for the year 2017.

SECTION 2: The amount levied for each object and purpose shall be as follows:

SECTION 3: That the Town Clerk shall make and file with the County Clerk of said County of Lake, on or before the last Tuesday of December, a duly certified copy of this ordinance.

SECTION 4: That the Board of Trustees does hereby certify that the amount levied herein is necessary to be raised by taxation for road purposes for Lake Villa Township Road District.

SECTION 5: That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such finding shall not effect the validity of the remaining portion of this ordinance.

SECTION 6: That this ordinance shall be in full force and effect after its adoption, as provided by law.


CERTIFICATE OF COMPLIANCE






