The Trustees would like to be able to defend Commissioner Jorgensen if a resident asked why Joe Meyer's service is the company used to cut down the trees in the Township. Highway Commissioner Jorgensen assured the board the tree service company has insurance before a tree is cut down. Possibly going out for bid based on a tree removal formula. Highway Commissioner explained there are so many variables regarding the cost for each tree that needs to be cut down. Highway Commissioner questioned what the procedure is needed to sell a Township truck to the Village of Lake Villa, Supervisor Venturi explained the procedure and it will be added the Nov 8<sup>th</sup> agenda.
